However, prop 98 would need to be changed to allow block grants to be lower than last year, so this is unlikely.

Lease is going up a lot, 30K next year, 23K two years after that.

Tim would like numbers for 2013-14 and 2014-15 to not be so conservative, since we will be coming up for charter renewal in a couple of years.

No raises are anticipated in next year's budget, but Kelly and Wendy salary/hours being restored; two teachers will receive full pay after finishing credentialed programs.

B. Fiscal Impact of summer classroom expansion

Setting up site committee for long-range planning.

A bigger upper el is expected next year due to a large third grade class (which started at River in 1st) moving up to 4th grade. Outgoing sixth grade class was smaller. Plan is for one more upper el classroom and one more upper el teacher. \$6,500 is set aside for facilities improvements One new teacher is budgeted.
